With an attractive payment structure, a spacious and well-proportioned two bedroom apartment, in phase 1 of Royal Wharf. The payment structure is 10% of purchase price to exchange contracts, 10% in June/July 2015 with 80% on completion. This property is available as an off-plan investment sale, with the right for multiple assignments, for completion in 2016. Royal Wharf will consist of 3,385 homes in total, a beautiful riverside walkway, new streets, connecting parks and squares, with the apartment buildings offering very generous 'family sized' apartments.


